Bids will be opened in the presence of Bidders' representatives who choose to attend at office on 14 hours on 2nd December 2021 (16/08/2078) at the office of Makalu Rural Municipality, Num, Sankhuwasabha. Bids must be valid for a period of 120 days after bid opening and must be accompanied by bid security, amounting to a given in Para. 9, which shall be valid for 30 days beyond the bid validity period.
