4. Bids must be submitted to the office of Makalu Rural Municipality, Num, Sankhuwasabha through [www.bolpatra.gov.np](http://www.bolpatra.gov.np), on or before **12 noon on 30<sup>th</sup> December 2021 (15/09/2078)**. Documents received after this deadline shall not be accepted.

Bids will be opened in the presence of Bidders' representatives who choose to attend at office on **14 hours on 30<sup>th</sup> December 2021 (15/09/2078)** at the office of Makalu Rural Municipality, Num, Sankhuwasabha. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by bid security, amounting to a given in Para. 9, which shall be **valid for 30 days** beyond the bid validity period. \*
