- 1) Makalu Rural Municipality Office has allocated fund and invites electronic bids from Nepalese eligible bidders towards Makalu Rural Municipality Building Construction, under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.
- 2) Eligible bidders to participate in the contract should have the following key qualifications.
  - a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years :- NRs 74 Millions
  - b) Minimum Work experience of similar size and nature :- At least one number with a value of at least NRs. 60 Millions that have been successfully or are substantially completed.
  - c) Bid Capacity:-NRs 99 Millions
  - d) Financial Resources:- NRs 21 Millions
  - e) Construction Experiences in Key Activities :-
    - i) Production rate per year Plain Cement Concrete (PCC) of grade M25 of approved quality in RCC works :- 400 Cum
    - ii) TMT Fe 500 Steel Reinforcement works :- 62900 Kg

- 6) Technical bids will be opened in the presence of Bidder's representatives who choose to attend at date and time ( as mentioned in the table below ). Bid should be valid for a period of 120 days after bid Opening and must be accompanied by a bid security minimum of Rs ( as mentioned in table below) which shall be valid for 30 days beyond the validity period of the bid .
