- 1) Makalu Rural Municipality Office has allocated fund and invites electronic bids from Nepalese eligible bidders towards Makalu Rural Municipality Building Construction, under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.
- 2) Eligible bidders to participate in the contract should have the following key qualifications .
 - a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years :- NRs 60510000.00
 - b) Minimum Work experience of similar size and nature :- At least one number with a value of at least NRs. 60509000.0000 that have been successfully or are substantially completed.
 - c) Construction Experiences in Key Activities :-
 - i) Plain Cement Concrete (PCC) of grade M20 of approved quality in RCC works :- 770 Cum
 - ii) TMT Fe 500 Steel Reinforcement works :- 126 MT
 - ii) Brick Masonry Work :- 510 Cum

Bid should be valid for a period of 120 days after bid Opening and must be accompanied by a bid security minimum of Rs (as mentioned in table below) which shall be valid for 30 days beyond the validity period of the bid .
